Sector related to OHTN mandate:

- OHTN including the organization, its programs or projects*
- Research including research project, program or organization*
- HIV / AIDS including research (all tracks), clinical or medical treatment, policy development, service delivery or community action*
- Health including health services, healthcare and health policy

 - Endemic countries/communities in Ontario
 - Newcomer (lived experience as immigrant)

- Drug users including IDU (intravenous drug user)
- Sex workers
- Prisoners (former prisoners not currently serving a sentence)
- Other Ethnic/cultural and visible minorities: African-Caribbean; African-American; Asian; South/Southeast Asian; etc.
